Despite vacations and the general attitude of summer relaxation, the Blue Mounds Project has been on the move! We are making progress toward the goals we set for ourselves at the annual meeting. Here's a quick rundown.

Our membership is holding steady. Renewals (check your mailing label for expiration) and new memberships trickle in even though we haven't given it any special effort...yet. Some kind of a membership campaign may be on the horizon. However, more importantly, we have achieved our goal of seven active board members. We have two great additions—John Bird and Peter Weil. John, a long time Town of Vermont resident, is bringing much appreciated professional accounting skills to the Treasurer's duties. Peter has become our official webmaster, providing much needed communications support. Our shelf at the Prairie Bookstore remains stocked and popular and has been moved to a more prominent location (thanks John!).

Our land stewardship and outreach efforts are renewed and strong, flexed by \$30,000 in grants from the Wisconsin DNR and Wisconsin Environmental Education Board. Most of this grant money is funding our forest stewardship project, which runs through next year. While our efforts will be more focused and concentrated on select properties, the Board remains committed to maintaining the initial concept of the Project by providing assistance to all members and conducting site visits for new members when possible.

Finally, we are making headway with bylaws and the paperwork for incorporation as a 501(c)3 nonprofit organization. We are on target for completion by the March 2001 annual meeting. One issue we are struggling with is the role of membership: is there sufficient interest among our members to participate in the election of the Board, or would it be better for the Board to be "self-perpetuating"? A self-perpetuating Board recruits and chooses its own Directors from the general

## BMP Receives Award From Iowa County Farmers

The Blue Mounds Project received the Wildlife Habitat-Club Award at the June Iowa County Farmers Appreciation Days. Alice in Dairyland presented Robert Wernerehl, Project Ecologist, with the award in recognition of our hard work to enhance habitat for wildlife in Iowa County. Numerous landowners in Iowa County have received assistance from the BMP.

Immediately following the presentation, local landowner and farmer Lee Fahrney, received the Wildlife Habitat-Private Landowner Award. In his acceptance speech, Fahrney praised the work of the BMP and Wernerehl saying "The Blue Mounds Project has a lot to offer the private landowner in terms of awareness and advice in restoring and protecting habitat." He went on to say, "Bob's visit was a very positive experience." Fahrney has conducted several projects on his land including tree plantings, prairie restoration, and wetland creation.

## Controlling Invasive Plants: A workshop for landowners

Sunday, October 8th, 2000 – 1 PM to 4 PM.

Invasive plants have become a major land management issue. You're probably familiar with a few of these common invasive species: garlic mustard, honeysuckle, buckthorn, multi-flora rose, wild parsnip, autumn olive, Japanese barberry, white mulberry, box elder, dame's rocket, and others. If you want a good diversity of native species and healthy, functioning natural systems on your land, these invasive plants are a serious threat and need to be controlled.

But what is the best way to control them? Come to this workshop and you will learn a variety of techniques! We'll show you simple methods for applying a glyphosate herbicide, such as Roundup. This type of herbicide is considered quite safe to use and bio-degrades very rapidly in the environment. We'll demonstrate the use of an interesting new herbicide application device called a "stem pick". These are small vials containing herbicide that fit over a cut stem and are left on so

that the plant slowly absorbs the herbicide. We will also show and discuss mechanical control methods such as propane torches, weed wrenches, and brush cutters.

We'll meet on the 120 acre farm of Pat Handrick, located 3 miles south of Mt. Vernon. Pat has been quite successful in controlling woody invasives and we'll view the fruits of his labor.

Wear sturdy boots, long pants, and bring or wear a long sleeve shirt. If you would like to try some of the tools and techniques, bring work gloves, rubber gloves, and safety glasses, if possible.

There is no fee, but registration is required. The workshop will be lead by Bob Wernerehl, The Blue Mounds Project Ecologist, and landowner Pat Handrick. ## **Sugar River Watershed Association to Host Picnic in the Park**

The Upper Sugar River Watershed Association (USRWA) is hosting a Picnic in the Park on Saturday, September 9, 2000 from 11:00 a.m. to 4:00 p.m. at Donald Park on Patricia Hitchcock's farm. The day's activities will include a business meeting, door prize drawing, tours, demonstrations, and a logo contest. Food and beverages will be provided.

Last winter, folks who live, work, and play in the Upper Sugar River Watershed met to share concerns for the watershed and discuss forming a watershed association. The group has been meeting ever since and has developed bylaws, elected officers and will be developing an action plan this fall. The group developed the following mission statement: The Upper Sugar River Watershed Association will serve as a forum for the preservation and enhancement of the watershed resources through an impartial partnership among diverse community interests.

As a first step towards this mission statement, USRWA is hosting a meeting to raise awareness of the watershed and its many treasures. You'll get to meet the interim board of directors and hear more about the formation of the Association. There will be a small business meeting at which the board will present the bylaws for adoption. Following the business meeting, there will be a door prize drawing including prints from local and national artists and other fabulous items. In the afternoon, there will be prairie and streambank tours. Come and see the what last year's habitat enhancement and streambank restoration project on Deer Creek looks like now. Demonstrations on fish assessment, fly fishing, fly tying, and the use of forestry equipment will be also be given.

*William Rudolph Smith, a gentleman traveler from Philadelphia, described the open character of the oak savanna near Blue Mounds during an 1837 visit:*

*“The groves surrounding, and interlacing, and sprinkling, and dotting the vast ocean of open field, can be threaded as easily with a carriage, as if you were driving through a plantation of fruit trees, set or growing irregularly. The undergrowth is generally of small bushes readily passed over, the black currant, the furred and smooth gooseberry, the red and the white raspberry, the blackberry, the haw, the wild plum, and the crabapple; all these indigenous fruits are found throughout the territory; the strawberry literally covers the prairies and the groves.”*
